The Treasury Department and Internal Revenue Service announced in March that the federal income tax filing due date for individuals for the 2020 tax year will be automatically <u>extended from April 15, 2021, to May 17, 2021</u>. Individual taxpayers can also postpone federal income tax payments for the 2020 tax year due on April 15, 2021, to May 17, 2021, without penalties and interest, regardless of the amount owed.

This postponement applies to individual taxpayers, including individuals who pay self-employment tax. Penalties, interest and additions to tax will begin to accrue on any remaining unpaid balances as of May 17, 2021.

Individual taxpayers will automatically avoid interest and penalties on the taxes paid by May 17. The IRS urges taxpayers who are due a refund to file as soon as possible. Most tax refunds associated with e-filed returns are issued within 21 days. If you need help getting your routing number and account number, contact your local office.

2021 Economic Stimulus Payments

If you haven't received one of the economic stimulus payments, you can find when and how it was sent. You must visit www.irs.gov/coronavirus/get-my-payment to check on it.

Didn't Get the First and Second Payments? Claim the 2020 Recovery Rebate Credit.

If you didn't get the full amount of the first or second payment you were eligible for, you may be eligible to claim the 2020 Recovery Rebate Credit and must file a 2020 tax return even if you aren't required to file. Visit www.irs.gov/newsroom/recovery-rebate-credit for more information.



NON-VISA Pinless Debit Transactions Annual Notice:

You may use your Visa Debit Card to initiate both Visa debit transactions and non-Visa debit transactions without using a person identification number (PIN) to authenticate trans-

To Initiate a Visa debit transaction, you may sign a receipt, provide a card number, or swipe you card through a point of sale (POS) terminal and choose to route the transaction over Visa network.

To initiate a Non-Visa debit transaction, you may enter a PIN at a POS or an online or a little set back for the holi-mail/phone order payment transactions, provide the account number and indicate a preference to route it as a non-Visa transaction.
