## SPRING CLEANING

NOW IS THE PERFECT TIME TO MAKE SURE ALL INFORMTION ON YOUR ACCOUNT IS UP-TO-DATE. MAKE SURE YOUR ADDRESS, PHONE NUMBER, AND EMAIL ARE ALL CORRECT. DOUBLE CHECK ANY AUTOMATIC WITHDRAWALS THAT ARE BEING DEDUCTED FROM YOUR ACCOUNT, AND CONFIRM THAT ANY JOINT OWNERS ON THE ACCOUNT ARE STILL NEEDED. IF A NON-SPOUSAL JOINT OWNER PASSES AWAY BEFORE THE PRIMARY OWNER, THE PRIMARY OWNER COULD BE SUBJECT TO PAY INHERITANCE TAX ON THEIR OWN MONEY. BE MINDFUL OF THIS IF YOU OPENED AN ACCOUNT FOR SOMEONE WHO IS NO LONGER A MINOR. POA'S CAN BE NOTED ON AN ACCOUNT TO BE SURE THEY CAN STILL ACCESS FUNDS WITHOUT DEALING WITH THIS ISSUE.

### DEALING WITH THE FRAUD DEPARTMENT

IF OUR FRAUD DEPARTMENT SEES A STRANGE TRANSACTION ON YOUR ACCOUNT, THEY WILL CALL YOU TO CONFIRM IF THE TRANSACTION BELONGS TO YOU OR NOT. THEY WILL INTRODUCE THEMSELVES AS FISERV AND THEY WILL CALL FROM A NEBRASKA NUMBER. IT IS VITAL THAT THE PHONE NUMBER ON YOUR ACCOUNT BE YOUR PRIMARY PHONE NUMBER SO THAT THEY CAN BETTER COMMUNICATE WITH YOU AND GIVE YOU A MORE SEAMLESS EXPERIENCE. IF FOR SOME REASON YOU ARE UNSURE IF IT IS GENUINELY THE FRAUD DEPARTMENT, HANG UP AND CALL AN OFFICE IMMEDIATELY SO WE CAN LOOK AT YOUR CARD. IF THE TRANSACTION IS DEEMED FRADULENT, THEY WILL CLOSE YOUR CARD. AFTER THAT, YOU WILL NEED TO CALL AN OFFICE TO REORDER A NEW ONE.






